



**BREEDING CONTRACT A.I.
SHIPMENT COOLED SEMEN
CURRAN FARM ROYAL CHIC OLENA 2008**

This Stallion Breeding Contract for the breeding season of 2008 is made and Entered into on this ____ day of _____ by and between CURRAN FARM (owner) hereinafter designated as Breeder and _____ (mare owner) Mare owner agrees to breed the mare _____ AQHA/APHA# _____ to the stallion ROYAL CHIC OLENA for the fee of \$ _____. One shipment is included in the breeding fee; (FED EX ONLY) if any more shipments are needed there will be a charge of \$250.00 per Shipment.

**The non-refundable fee of \$500.00 is for the booking fee and for expenses for collection/shipment of cooled semen. (This includes first shipment Fed EX only)
In 2008 our breeding days will be Mondays, Wednesdays, and Fridays. Please call and let us know when you have started to check mare and have her put on our board. As soon as mare is checked ready to breed by vet call us 24 hours ahead of ship date but no later than 7:00 am Central Time on the day of shipping. Same day shipment by Air (must be ordered 24 hours Before) \$250.00 ship fee and a \$150.00 extra for air shipments.(Total for Same Day Air is \$400.00)**

**This contract contains a normal "LIVE FOAL GUARANTEE" A live foal as described as a newborn foal, which stands and nurses without assistance. If foal is born dead, there are return privileges for the year 2009 breeding season, providing the mare owner notifies the Breeder within 10 days of the death confirmed by the attending veterinarian. The only recurrent charges will be those charged for a rebred fee of \$250.00 and all shipping costs. (\$250.00 each shipment, FED EX only)
If mare fails to settle for any reason the mare owner will hold the breeder blameless.**

A breeders certificate will be issued for the foal only after all stallion fees and all other expenses are paid in full and Curran Farm has been notified a live foal has been produced by this mating.

It is further agreed that should the stallion die, or become unfit for service prior to settling the mare, the breeding fee minus the booking fee of \$500.00 will be refunded.

Incurred vet/shipping expenses will not be refunded. If the mare dies or becomes unfit for breeding before being checked safe in foal, the Breeder has the option to accept another mare as a replacement.

This contract is non-assignable and non-transferable; the mare owner is responsible for all sales taxes on shipping semen.

On mares that did not settle in 2007 there will be \$250.00 rebred fee plus all shipping costs.

This contract is entered into in the State of Texas and will be interpreted and enforced by the laws of this State in the County of Cooke.

If any clause in this contract is against State Law, then that clause only shall be null and void but the remaining contract shall remain binding in its entirety.

When Mare Owner and Breeder sign this contract, it will be binding on both parties.

Please sign and copy and keep for you records, and return original to Curran Farm.
